

**SUMMARY ANNUAL REPORT**  
**For**  
**SEIU Local 1 & Participating Employers Health Trust**

This is a summary of the annual report of SEIU Local 1 & Participating Employers Health Trust, EIN 36-2857218, Plan No. 501, for period October 1, 2019 through September 30, 2020. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

**Insurance Information**

The plan has contracts with Union Health Services, Inc. (UHS) and Blue Cross Blue Shield of Illinois (BCBSIL) to pay certain Medical, Dental, Vision, and Prescription drug claims incurred under the terms of the plan. Total premiums paid to UHS for the policy year ending December 31, 2019 were \$42,021,470. Total premiums paid to BCBSIL for the policy year ending July 31, 2020 were \$3,480,735.

**Basic Financial Statement**

The value of plan assets, after subtracting liabilities of the plan, was \$138,751,862 as of September 30, 2020, compared to \$112,772,723 as of October 1, 2019. During the plan year the plan experienced an increase in its net assets of \$25,979,139. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$140,988,514, including employer contributions of \$132,516,957, employee contributions of \$197,413, realized gains of \$66,192 from the sale of assets, earnings from investments of \$7,845,223, and other income of \$362,729.

Plan expenses were \$115,009,375. These expenses included \$2,870,347 in administrative expenses, and \$112,139,028 in benefits paid to participants and beneficiaries.

The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
