# SUMMARY ANNUAL REPORT FOR SEIU LOCAL 1 & PARTICIPATING EMPLOYERS HEALTH TRUST

This is a summary of the annual report for SEIU Local 1 & Participating Employers Health Trust, EIN 36-2857218, for the year ended September 30, 2023. The annual report has been filed with the Employee Benefit Security Administration as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The Board of Trustees of SEIU Local 1 & Participating Employers Health Trust have committed themselves to pay certain claims incurred under the terms of the plan.

### **Insurance Information**

The plan has contracts with Blue Cross Blue Shield of Illinois to pay dental claims and Union Health Service, Inc. to pay medical, vision and prescription drug claims incurred under the terms of the plan. The total premiums paid for the policy periods ending July 31, 2023 and December 31, 2022 were \$2,994,818 and \$44,007,064, respectively.

#### **Basic Financial Statement**

The value of plan assets, after subtracting liabilities of the plan was \$149,846,699 as of September 30, 2023, compared to \$138,623,267 as of October 1, 2022. During the plan year, the plan experienced an increase in its net assets of \$11,223,432. This increase included unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$146,585,430 including (but not limited to) employer contributions of \$139,262,678, participant contributions of \$201,983, gain of \$236,896 from the sale of assets, net investment earnings of \$6,469,798 and other income of \$414,075.

Plan expenses were \$135,361,998. These expenses included \$3,570,200 in administrative expenses, and \$131,791,798 in benefits paid to participants and beneficiaries.
